# 56<sup>th</sup> GST COUNCIL MEETING Rate Notification- Goods



#### **GST Notification pursuant to 56th GST Council Meeting**

Further to our earlier update (08/2024-25) on the recommendations made in the 56th GST Council Meeting, we wish to bring to your attention the following developments:

- Notification No. 09/2025-CTR Supersedes Notification 01/2017-CTR and notifies the revised GST rate schedules for goods, with slabs of 2.5%, 9%, 20%, 1.5%, 0.125%, 0.75% and 14%.
- Notification No. 10/2025-CTR Supersedes Notification 02/2017-CTR and specifies new list of goods exempted from GST.
- Notification No. 11/2025-CTR Amends Notification 03/2017-CTR (in connection to petroleum operations) by substituting the applicable GST rate entry to 9%
- Notification No. 12/2025-CTR Amends Notification 08/2018-CTR (in connection to GST rate on used motor vehicles) by updating references to new schedules (Schedule II/III of 09/2025).

- Notification No. 13/2025-CTR Prescribes concessional 2.5% GST on specified handmade and handicraft items such as candles, handbags, carved wood, handmade carpets, embroidered shawls, handmade paintings, etc..
- Notification No. 14/2025-CTR Introduces 6% GST on construction materials such as fly ash bricks, blocks, building bricks, and earthen roofing tiles.
- Notification No. 15/2025-CTR Amends Notification 11/2017-CTR relating to supply of services; key changes cover petroleum services, job work services, transport services (rail, multimodal, containers, etc.) and input tax credit conditions.
- Notification No. 16/2025-CTR Amends Notification 12/2017-CTR relating to exempt services; exempts life and health insurance for individuals/families, and clarifies GST treatment of local delivery services through e-commerce operators
- Notification No. 17/2025-CTR Amends Notification 17/2017-CTR to bring local delivery services under Section 9(5), making the e-commerce operator liable to pay tax.
